Applicant acknowledges and understands that Memberships are issued in the sole and absolute discretion of the Trustees or Officers of the Association.

Concurrently with submission of this Application, Applicant will remit to the Association a deposit equal to full payment for the membership initiation fee and/or membership level, unless the Association agrees in writing to a different arrangement. Payment toward the required Membership Fee, with the balance of the Membership Fee and Member Level due and payable immediately upon approval of this Application. Applicant further understands that Membership Application Fee and recurring Level fees selected by Applicant will be earned in full upon submission of Application or upon execution of a Promissory Note for the full payment of the Membership Level(s), including acceleration of the note payments if there is a default of the Promissory Note or Rules. Applicant acknowledges and agrees that notwithstanding the approval of this Application, Applicant's Membership shall not become effective unless and until there has been full payment of the Membership Fee and any Membership Level(s) and other charges due and payable at the time of approval as provided under the Rules, and to the extent Applicant is allowed to utilize the membership. Applicant is only temporarily licensed to utilize the Membership at the sole and absolute discretion of the Association. In the event Applicant is accepted for Membership, Applicant agrees to timely payment of all Membership Fees, including Promissory Note payments, and other charges that accrue from time to time respecting such Membership.

Applicant hereby confirms that all information and representations contained in or supplied in connection with this Application are true and correct in all respects and understands that should such information later prove to be false, then this Application shall become null and void at the sole and absolute discretion of the Trustees or Officers of the Association. Applicant hereby authorizes Trustees or Officers to seek independent verification of the information provided in this Application. By Applicant's signature below, Applicant authorizes to release any and all information requested by Trustees or Officers of the Association.

Applicant understands that the information contained in this Application and any such requested information will be held in confidence by the Trustees and the Officers. Applicant understands that any representations of any kind are not part of this Agreement if not included herewith, hereto, or by reference, such as the Rules, as set forth herein. Nothing in this Agreement predicts or guarantees future results. The Association is not liable for the use or interpretation of information conveyed in the execution of this Agreement. The Association expressly disclaims all liability for any actions Members take or do not take, based on this Agreement's content and execution. Applicant understands that the Member(s) will be required



to pay all requested costs incurred outside of the Membership Fee, Membership Level(s). Any costs include but are not limited to filing fees, attorney's fees, paper and postage fees incurred directly or indirectly in collecting on unpaid debts from Member(s) to the Association.
